The Provisional affiliation is subject to the following conditions:

- To follow and observe the norms of BCI and University Act, Statutes, Ordinances.

 Regulations, Rules and Instructions framed, amended, adopted and issued from time to time relating to:-
 - (a) Admission of only eligible students will be made.
 - (b) To follow curricular courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
 - (c) Appointment of Teaching/Sports/Library Staff within stipulated period.
- II (i) Staff- Appointment of permanent and qualified Principal and teaching staff on full time basis selected by duly constituted committees and appointment will be got approved from the University.
 - (ii) Building Construction of sufficient building as per guide lines of the University provisions, play grounds and hostel building.
- Library- Year wise development of college Library and provision of funds for journals and magazine be made. Year wise bifurcation of books purchased-details be submitted.
- Endowment Fund- Sufficient endowment fund as prescribed in rules be created & University will be supplied a copy F.D.R. etc. in the name of Registrar & Management Committee.

 V. (a) Number of admission will be restricted to the supplied as the supplied a
 - (a) Number of admission will be restricted to the number of seats allotted by the University. No admission over and above the number of seats allotted will be made.
 - (b) No admissions may be given in the subject(s)/course(s) without obtaining the affiliation in the subject(s)/course(s) concerned.

Non compliance will entail severe action against the college as per the letter No. 31170-313 dated 23-02-2006 and responsibility for the same will be with the College Administration.

- VI. No affiliated institution shall be allowed to discontinue the study of any Subject/Faculty without prior permission of the University. An application for such permission shall be made to the Registrar by the Head of the institution duly forwarded by the Management at least one full academic year in advance, giving reasons in support of the proposal.
- VII. Every college not maintained by the Government shall satisfy the Board that adequate financial provision is available for its efficient maintenance. If at any time the governing body of a College be unable to run the College, it shall inform the Board at least one full academic year in advance and shall give a notice of similar duration, viz., one full academic year to the employees of the institution for termination of their services: Provided that the closure of an Institution shall be in gradual stages in respect of each course of study for which it is affiliated, starting from the first year of the course.
